Driver Ed Academy.com will furnish a licensed instructor and vehicle for behind the wheel training. Classroom and driving instruction will be conducted in Hamilton, Butler, and Warren Counties. Regulations prohibit more than four hours of classroom training and three hours of behind the wheel training to be conducted in any given day. Additional individual behind the wheel lessons are available for a fee of **\$119.00 per 1.5 hour of instruction**. **Driver Ed Academy.com** is not responsible for providing a vehicle for the state exam unless purchasing in an advanced package. However, **the school** can provide a vehicle for the exam with an additional fee of **\$149.00 paid prior to state testing**.

The student may begin classroom instruction at age 15 years and 5 months, and before obtaining a temporary driving permit. However, the student is required to obtain a valid temporary driving permit and pay tuition in full prior to scheduling the practical driving portion of the training. **If the student must cancel a scheduled driving lesson, cancellation must be made 48 hours prior to the scheduled appointment. Failure to do so will result in an additional fee of \$50.00.** The same fee shall apply should the student fail to appear for or does not have their temporary permit in possession at the time of the scheduled lesson or for any reason not prepared to take the scheduled lesson. **Behind the wheel lessons will be scheduled after the 24 hrs of classroom training is completed.** ___ Intls. Driver Ed Academy.com will make available the complete course "Based on the Ohio Driver Training Curriculum", to be finished within six months of first date of training.
